PRIVACY POLICY

Powered By Love, Inc. (“we,” “us,” or “our”) respects your privacy and is committed to protecting your personal information. This Privacy Policy explains how we collect, use, and disclose information when you visit our website, poweredbylove.org, and when you engage with our services.

1. Information We Collect

We may collect the following types of information:

- **Personal Information:** When you donate, register for events, subscribe to our newsletter, or fill out a form on our website, we may collect personal information such as your name, email address, mailing address, phone number, and payment information.
- **Non-Personal Information:** We may collect non-personal information about your visit to our website, including your IP address, browser type, operating system, and browsing behavior. This information is collected through cookies and similar technologies.

2. How We Use Your Information

We use the information we collect for the following purposes:

We do not sell, trade, or rent your personal information to third parties. However, we may share your information with:

These service providers are bound by confidentiality agreements and are only permitted to use your information for the purposes specified by us
- **Legal Requirements:** We may disclose your information if required to do so by law or in response to a subpoena, court order, or other legal processes.

4. Cookies and Tracking Technologies

Our website uses cookies and similar tracking technologies to enhance your experience and gather information about how our site is used. You can choose to disable cookies through your browser settings, but this may affect your ability to use certain features of our website.

5. Security of Your Information

We take reasonable precautions to protect your personal information from unauthorized access, use, or disclosure. However, no method of transmission over the internet or method of electronic storage is completely secure, and we cannot guarantee absolute security.
